ORDINANCE #9-23

AN ORDINANCE TO AMEND CHAPTER 46 OF THE BOROUGH CODE OF THE BOROUGH OF MAYWOOD ENTITLED "OFFICERS AND EMPLOYEES"

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MAYWOOD, IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS FOLLOWS:

WHEREAS, the Mayor and Council of the Borough of Maywood revise Chapter 46 of the Borough Code so as to add a new Sec. 46-4 to set forth additional election compensation.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Maywood, County of Bergen as follows:

Section 1: Chapter 46. Officers and Employees

Article 1. Borough Clerk

Sec. 46-4. Borough Clerk Compensation, Additional.

The Borough Clerk shall receive compensation as fixed annually by the Borough Council. Additionally, when the Borough Clerk is required to be present at an election or election-related matter during a time when other municipal employees are off, such as late-night voter registration, primary election day and general election day, he or she will receive additional pay for such time spent at a rate of pay calculated at time and a half (1.5) of the then year current hourly rate.

Section 2: All ordinances of the Borough of Maywood which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 3: If any section, subsection, sentence, clause or phrase of this ordinance if, for any reason, is held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

Section 4: This ordinance shall take effect upon passage and publication according to law.
