ORDINANCE #13-22

AN ORDINANCE TO AMEND CHAPTER §169-1 GOVERNING THE BOROUGH OF MAYWOOD'S SCHEDULE OF FEES SO AS TO ADD A SCHEDULED FEE FOR CANNABIS BUSINESS LICENSES AND RENEWALS

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MAYWOOD, IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS FOLLOWS:

WHEREAS, the Mayor and Council of the Borough of Maywood deem it necessary to set the licensing and licensing renewal fees for cannabis business within the Borough;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Maywood, County of Bergen, as follows:

Section 1: Chapter § 169-1 which contains the Schedule of Fees for the Borough of Maywood is amended to add a subsection section for the Department of Public Works and the following fee for property maintenance remediation:

Section 4: This ordinance shall take effect upon passage and publication according to law.
