ORDINANCE #14-23

CAPITAL ORDINANCE OF THE BOROUGH OF MAYWOOD, IN THE COUNTY OF BERGEN, NEW JERSEY AUTHORIZING THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS IN, BY AND FOR THE BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$1,696,054.41 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM CAPITAL SURPLUS OF THE BOROUGH AND FROM VARIOUS GRANTS

BE IT ORDAINED by the Borough Council of the Borough of Maywood, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Maywood, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to make the following public improvements in, by and for the Borough: (A) undertaking of the Memorial Park Improvement Project; (B) installation of EV charging stations at various locations; (C) replacement of concrete decking at Memorial Pool; and (D) resurfacing of basketball courts and conversion of a basketball court to a pickleball court at Memorial Park. Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$1,696,054.41 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as the "improvements"). Said appropriation shall be raised from Capital Surplus of the Borough and from various grants, as hereinafter provided. The sum of \$1,446,054.41 is hereby appropriated from Capital Surplus of the Borough to the payment of the cost of the improvements. The aggregate amount of \$250,000 in grants is hereby appropriated to the payment of the cost of improvements, as follows: (A) \$25,000 from the State of New Jersey Department of Environmental Protection for the installation of EV charging stations; (B) \$150,000 from the County of Bergen Open Space, Recreation, Floodplain Protection, Farmland and Historic Preservation Trust Fund for the

improvement of Memorial Pool; and (C) \$75,000 from the New Jersey Department of Community Affairs for the basketball and pickleball court improvements at Memorial Park.

Section 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
