ORDINANCE #14-24

**AN ORDINANCE TO AMEND CHAPTER 65 OF THE BOROUGH CODE OF THE
BOROUGH OF MAYWOOD ENTITLED "PUBLIC WORKS, DEPARTMENT OF"**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF
MAYWOOD, IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS
FOLLOWS:**

WHEREAS, the Mayor and Council of the Borough of Maywood revise Chapter 65 of the Borough Code so as to amend Sec. 65-4 to set forth overtime pay for the Superintendent of the Department of Public Works.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Maywood, County of Bergen as follows:

Sec. 65-4. Supervisor and other employees.

Letter A. New paragraph (5) The Superintendent of the Department of Public Works shall be entitled to overtime pay for hours worked relating to issues with regard to snow only and shall be compensated for such time spent at a rate of pay calculated at 1.5 of the then year hourly rate.

All ordinances of the Borough of Maywood which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

If any section, subsection, sentence, clause or phrase of this ordinance if, for any reason, is held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

This ordinance shall take effect upon passage and publication according to law.
