ORDINANCE #17-22

AN ORDINANCE TO AMEND CHAPTER 312 SUBCHAPTERS 7 (D) OF THE BOROUGH OF MAYWOOD CODE GOVERNING THE PARKING OF VEHICLES IN THE BOROUGH OF MAYWOOD, STATE OF NEW JERSEY

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MAYWOOD, IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS FOLLOWS:

WHEREAS, the Mayor and Council of the Borough of Maywood wishes to amend Chapter 312-7 (d) to authorize a 15-minute parking spot in front of 102 West Pleasant Avenue to assist those members of our community that may have special needs.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Maywood, County of Bergen, as follows:

Section 1: the schedule of spaces enumerated in Chapter 312-7 (d) which prohibits the parking of any vehicle for longer than 15 minutes between the hours of 9:00 a.m. and 6:00 p.m. on any day except Sunday and public holidays shall be modified to add the following parking space:

Section 2: All ordinances of the Borough of Maywood which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 3: If any section, subsection, sentence, clause or phrase of this ordinance if, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

Section 5: This ordinance shall take effect upon passage and publication according to law.
