ORDINANCE #3-22

**AN ORDINANCE TO AMEND CHAPTERS §52-81 AND §52-82 GOVERNING
CLOTHING ALLOWANCES FOR THE BOROUGH OF MAYWOOD'S VOLUNTEER
FIRE COMPANIES AND THE FIRE POLICE**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF
MAYWOOD, IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS
FOLLOWS:**

WHEREAS, the Mayor and Council of the Borough of Maywood wish to update Borough Code so as to provide an increase to the clothing allowances for the Borough of Maywood's volunteer fire companies and the fire police to reward members for their loyal, diligent and devoted services to the residents of Borough of Maywood.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Maywood, County of Bergen, as follows:

Section 1: Chapter § 52-81 is amended to increase the annual clothing allowance of the fire police which shall now read as:

§ 52-81 Fire Police allowance.

There is hereby established a clothing allowance, in an amount not to exceed \$1,260.00 per year, per member of the Fire Police, payable in the last pay period of November of each year, subject to the appropriation annually of sufficient funds therefor. The Fire Police shall include, within its bylaws, eligibility criteria of its members to qualify for the clothing allowance or part thereof. Such criteria shall not be effective unless and until approved by a resolution of the Mayor and Council. In the absence of such criteria, the Mayor and Council may, by resolution, establish criteria and calculate such clothing allowance.

Section 2: The schedule of allowances in Chapter § 52-81 is amended to increase the annual clothing allowance of the fire department which shall now read as:

Position	Base Clothing Allowance
Chief	\$2,500.00
Assistant Chief	\$1,900.00
Deputy Chief	\$1,800.00
Captain	\$1,700.00
Engineer of Rescue	\$1,700.00
Lieutenant	\$1,600.00
Assistant Engineer of Rescue	\$1,600.00
Firefighter	\$1,500.00

Section 3: All ordinances of the Borough of Maywood which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 4: If any section, subsection, sentence, clause or phrase of this ordinance if, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

Section 5: This ordinance shall take effect upon passage and publication according to law.
